# SAILING INSTRUCTIONS

The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.  
(RRS Fundamental Rule 4)

## 1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2 RRS part 2 will be replaced with the right-of-way rules of the International Regulations for Preventing Collisions at Sea (IRPCAS) between the times of local sunset and sunrise; or government right-of-way rules, if applicable.
- 1.3 World Sailing Offshore Special Regulations Category 1 with RORC Prescriptions.
- 1.4 The rules and regulations of appropriate Class rules; IRC Rules Parts A, B & C; Class 40 and MOCRA Rules.

## 2 EQUIPMENT AND MEASUREMENT CHECKS

- 2.1 A boat or equipment may be inspected at any time for compliance with the rules and Sailing Instructions.

## 3 NOTICES TO COMPETITORS

- 3.1 Notices to competitors will be posted on the Official Notice Board located in the window of the RORC Office Cowes before the start. Notices may also be displayed on the RORC website.

## 4 ENVIRONMENTAL RESPONSIBILITY AND POLLUTION

- 4.1 The RORC and its sponsors are keen to ensure all competitors are aware of their environmental responsibilities and the enormous impact rubbish pollution can have on the marine environment.
- 4.2 With these responsibilities, and the commitment to green racing, competitors are reminded of NOR 1.2.7 relating to pollution "*RRS 55 (Trash Disposal) is deleted. However, competitors are reminded that the dumping of rubbish at sea is prohibited by law. Attention is also drawn to the World Sailing Code of Environmentally Friendly Behaviour. ## 5 NOTICE TO MARINERS

- 5.1 Competitors are reminded of their responsibility to take account of all Notice to Mariners and should be particularly aware of:
- 5.2 Port of Southampton Precautionary Area – (Thorn Channel)  
Competitors are reminded to maintain a constant watch for shipping movements, particularly in the Port of Southampton Precautionary Area (Thorn Channel).  
Your attention is drawn to the ABP Notice to Mariners No.3 of 2016 which covers the movement of shipping and the accompanying sound signals that may be heard. See:

## 6 BACKSTAY FLAGS

- 6.1 Sevenstar backstay flags will be provided and shall be flown for at least one hour before & after the start and also for one hour after the finish. Should a flag not be able to be flown from a backstay, a boat shall fly it from the starboard shroud.
- 6.2 All boats shall fly a RORC backstay flag. Flags shall be flown from the backstay or appropriately visible point near the back of boats without backstays, a minimum of 1.5 meters above the deck.

## 7 OFFSHORE TRACKERS AND AIS

- 7.1 All boats will be provided with a YB Tracker. The tracker must be carried at all times in the prescribed location.
- 7.2 No boat shall interfere with, or disable, any YB Tracker throughout the period of the race.
- 7.3 All boats are required to have their AIS transceivers switched on and able to transmit (at least every 5 minutes) and receive at all times throughout the race.
- 7.3.1 All AIS equipment in addition to the MMSI number must transmit the boat's current racing name, speed and course over the ground.

## 9 IDENTITY GATE

- 9.1 An identity gate will be established between Party buoy (yellow buoy in approximate position 50° 46'.10N 001° 18'.43W) and a gate vessel displaying a blue flag with a white border and a white seahorse over a yellow flag lying to the north of Party buoy.
- 9.2 The gate will be available from ninety minutes before the first start until about ten minutes after the last start, or later at the discretion of the committee. Each boat shall pass once through the gate in an easterly direction with her engine running, displaying her sail numbers and letters secured to the lifelines on the port side. In addition a **lifejacket, safety harness and safety line shall be worn by each member of the crew (in accordance with Special Regulations 5.01 and 5.02)** and the boat shall receive visual acknowledgement before starting.  
**Warning:** Boats which do not pass through the gate correctly are liable to disqualification.
- 9.3 After the start when sail numbers are not displayed elsewhere (sails down) they shall be displayed secured to the lifelines on the port quarter.

## 10 NUMBER OF PERSONS ABOARD

- 10.1 **After leaving the dock to race but not before 1000 and before passing through an identity gate each boat shall send an SMS (text) message from the declared onboard mobile phone to: +44 (0) 7797 805 885. The SMS (text) message shall contain the boat name, sail number and number of persons on board.**
- 10.2 If the number of persons on board is less than that declared on RORC Sailgate then the full names of the persons not onboard shall also be included in the SMS message.
- 10.3 A boat shall not sail with a crew member whose Emergency Contact details have not been lodged on Sailgate before the start of the race.
- 10.4 **Warning:** Boats which do not correctly SMS (text) crew numbers or persons not on board are liable to disqualification.

## 11 STARTING TIMES AND SIGNALS

- 11.1 The race will be started by using RRS 26, with the warning signal being made 10 minutes before the starting signal.

## 12 STARTING LINE

- 12.1 The starting line is formed by bringing the Royal Yacht Squadron's flagstaff into line with the white line on the orange diamond on the Castle. (As an aid to competitors vertical light beams are installed at the RYS to identify the starting line transit. The intensity of the light beam increases as you approach the line but the lights are

momentarily obscured by the forward mast when you are on the line. The lights are navigational aids only and do not constitute the starting line. Any failure of this equipment shall be disregarded).

12.2 The start will be to the East:

**Outer limit:** (which is not on the starting line) South Bramble Buoy; leave to Port.

**Inner limit:** (which is not on the starting line) red/orange inflatable buoy up to 0.1nm from the RYS flagstaff; leave to Starboard.

## 13 LATE AT THE START

13.1 If a boat which has not previously come to the starting area is not off her moorings at her preparatory signal and comes to the starting area under power or being towed, shall stop her engine (or drop the tow) and complete a Two-Turns penalty as specified in RRS 44.2 before starting. No penalty will be imposed for an infringement of RRS 42. This changes RRS 42 and 45.

## 14 AREAS THAT ARE OBSTRUCTIONS

14.1 A boat shall not enter an area designated as an Obstruction.

14.1.1 All Traffic Separation Schemes (TSS) are designated as obstructions. A list of TSS and their positions are listed in Addendum A.

14.1.2 All oil and gas installations have a 500 metre exclusion around them by law and are shown on the most recent charts. These exclusion areas are designated obstructions.

14.1.3 All wind farm construction areas have a 500 metre exclusion around them by law and are shown on the most recent charts. These exclusion areas are designated obstructions. Information about the latest Offshore Renewable Energy Installations (OREIs) are available via the latest Notice to Mariners.

14.2 Additionally, racing boats shall not:

14.2.1 Pass to the South of Snowden Buoy off Cowes.

14.2.2 Pass to the North of Horse Sand Fort

14.2.3 Pass to the South of No Man's Land Fort

## 15 THE COURSE

15.1 The course is around Britain and Ireland to Starboard. The full course is listed in Addendum B.

## 16 COMMUNICATIONS

16.1 The Race Committee may broadcast information on VHF Ch.72, Callsign "Ocean One".

**16.2 Boats are reminded of their legal obligation to keep a continuous watch on VHF Ch.16.**

16.3 Boats are required to have their onboard mobile phone switched on at all times.

16.4 Reporting In Rough Weather (Force 7 and above)

16.4.1 In the event of rough weather all boats shall endeavour to report to the Race Committee their whereabouts and status at reasonable intervals (if possible 4-hourly), and pass on information about other boats if known.

16.5 When required, progress reports should be delivered by text message (+44 (0) 7797 805885) or email (racing@rorc.org)

16.5.1 Progress reports should include:

Name of boat and Sail Number

Date/time/mark being rounded (BST)

Course and Speed over the Ground

Wind Direction and Speed

Names of any boats nearby

16.6 In the event of the failure of the YB Tracker or AIS the Race Committee will require individual boats to report on a regular basis. Boats will be notified on an individual basis.

16.7 Inter-boat communication calls should when possible be on DSC or VHF Ch16 as a calling channel and VHF Ch72 as a working channel.

16.8 Boats with communications in addition to VHF should act as a link, taking other boats' reports on VHF and passing them to the Race Committee or Coastguard.

## 17 TIME LIMIT

17.1 There is no time limit for the race.

## 18 THE FINISH

- 18.1 The finishing line is formed by bringing the Royal Yacht Squadron's flagstaff into line with the white line on the orange diamond on the Castle. The Outer limit is South Bramble Buoy (which is not on the finishing line) and should be left to Starboard.
- 18.1.1 All boats are required to try and inform the Race Committee, Callsign "Ocean One", by VHF when passing No Man's Land Fort towards the finish.
- 18.2 To aid with identification, when finishing at night, boats are requested to shine a spotlight on their sail numbers and call "Ocean One" on VHF Ch.72 immediately after finishing.
- 18.3 Boats are reminded to take their own finishing times (BST) together with the names of the boats ahead and astern, if any. Finishing times shall be delivered to the RORC as soon as possible using a Declaration Form.

## 19 RACE FINISH DECLARATIONS

- 19.1 After finishing or retiring, boats shall complete and submit a Declaration Form to the Race Committee as soon as possible, but **not later than 24 hours after the end of the race**. Every member of the crew shall sign the Declaration Form. Failure to comply with this rule may result in the boat being excluded from the results. When a boat retires from a race she shall write the reasons on her Declaration Form.
- 19.2 When after a race a boat cannot promptly deliver the Declaration Form she shall without delay telephone the Race Committee, confirm that she has finished racing and give her time of finishing in BST. In this case the completed Declaration Form may be scanned and emailed to [racing@rorc.org](mailto:racing@rorc.org)

## 20 RETIREMENTS AND NON STARTERS

- 20.1 Retirements and non-starters must promptly inform the Race Committee or the Coastguard. It is imperative that boats that are no longer competing can be excluded from any Search and Rescue operation. **Failure to comply with this rule may lead to disqualification or exclusion from future RORC racing.**

## 21 USE OF ENGINE

- 21.1 When a boat uses its engine, e.g. to avoid collision, in a grave emergency, or as per SI 22 Temporary Discontinuance of Racing, the facts shall be reported on her Declaration Form.

## 22 TEMPORARY DISCONTINUANCE OF RACING

- 22.1 If a boat temporarily stops racing, they shall immediately inform the Race Committee explaining the circumstances and their plan by text message (+44 (0) 7825 007 035) or email ([racing@rorc.org](mailto:racing@rorc.org)).
- 22.2 If a boat makes fast in order to take shelter or in an emergency, the crew may temporarily leave the boat to handle her moorings. If she uses her engine for propulsion she shall, on rejoining the race, return to the spot where she began to use her engine, turn off her engine and continue to race from that spot. She shall report the circumstances on her Declaration Form. This changes RRS 45 and 47.2.

## 23 PENALTY SYSTEM

### 23.1 Scoring Penalties:

- 23.1.1 When the right-of-way rules of IRPCAS apply (between the hours of sunset and sunrise) a scoring penalty applies (RRS44.3).
- 23.1.2 The scoring penalty will be 10 minutes added to the boat's corrected time for each penalty. A boat that has taken a scoring penalty shall include full details on her Declaration Form. This adds to RRS 44.3.
- 23.1.3 When a scoring penalty does not apply, a yacht may take a Two Turns Penalty for breaking a rule of RRS Part 2 or a One Turn Penalty when she may have broken RRS 31, as described in RRS 44.2.

### 23.2 Standard Penalties:

- 23.2.1 When at a boat's starting signal she is subject to RRS 29.1 (Individual Recall) and she fails to comply with RRS 29.1 to start correctly, the Race Committee shall, without a hearing, apply a standard time penalty of 20%. This changes RRS63.1 and A5.
- 23.2.2 For a breach of RRS 28 (Sailing the Course) the Race Committee shall, without a hearing, apply a standard time penalty of 30%. This changes RRS63.1 and A5.
- 23.2.3 For a breach of any area designated an Obstruction, i.e. Traffic Separation Schemes, the Race Committee shall, without a hearing, apply a standard time penalty of 20%, unless the breach was unintentional, and no advantage gained. This changes RRS63.1 & A5.
- 23.2.4 Should the Race Committee consider a standard penalty to be inappropriate, it may protest the boat.

23.2.5 If, in a hearing brought by the Race Committee under Sailing Instruction 23.2.4, or by another boat, a boat is found to have infringed RRS 28, 29.1 or Sailing Instruction 14 the penalty will be at the discretion of the Protest Committee, but will not be less than the standard penalty.

### 23.3 Grounds for Protest

23.3.1 Breaches of SI 6, 9 and 16 will not be grounds for protest by a boat. This changes RRS 60.1a.

### 23.4 Other Penalties

23.4.1 When the Protest Committee decides that a boat that is party to a protest hearing has broken a rule other than RRS Part 1 and 2 and that no serious damage or injury was caused and no significant advantage has been gained, it may apply a time penalty of up to 20%. Should the Protest Committee decide that the breach was minor and unintentional it may at its discretion apply a different penalty.

## 24 PROTESTS AND REQUESTS FOR REDRESS

24.1.1 Protests may be written on plain paper, but Protest forms are available at the Race Office. Protests and requests for redress or reopening shall be delivered there within the appropriate time limit.

24.1.2 The protest time limit is 3 hours after the protesting boat finishes.

24.1.3 Notices will be posted no later than 30 minutes after the protest time limit for the last boat to finish the race.

24.1.4 The notification of a Protest by the Race or Protest Committee against a competitor as required under RRS 61.1(b) or (c) shall consist of a notice on the Official Notice Board at the finish.

## 25 SCORING

25.1 The Scoring System for Offshore Races, defined in Notice of Race 1.12.2, will apply.

25.2 The scoring abbreviation for a Standard Penalty is "SP".

26.2 Medallions:

26.2.1 RORC medallions will be presented as prizes for each class and division as follows:

26.2.2 When there are fewer than 6 starters in a class it may be combined for prizes with a neighbouring class.

## 27 RISK STATEMENT

27.1 Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

27.2 Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- they are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- they are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- they accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission;
- their boat is in good order, equipped to sail in the event and they are fit to participate;
- the provision of a race management team and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;

f) they are responsible for ensuring that their boat is equipped and seaworthy so as to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed, in date and familiar to the crew.

## **28 INSURANCE**

28.1 Each boat shall ensure that their boat is adequately insured, against all third party claims.
